The archival records in the Jesuit Archives: Central United States are the property of the Central and Southern, Chicago-Detroit, and Wisconsin Provinces of the Society of Jesus.

The Jesuit Archives: Central United States holdings include papers of closed Midwest Jesuit institutions and parishes, early records that concern continuing Jesuit institutions such as Saint Louis University or Marquette University, and files, photographs, books and periodicals related to deceased Jesuits of the four provinces.

The Jesuit Archives: Central United States reserves the right to restrict access to archival records. Archival materials are subject to the Access Policy of the Jesuit Archives: Central United States. The researcher promises to use professional discretion in treatment of any information obtained from the Jesuit Archives: Central United States.

Copies may not be duplicated or deposited elsewhere without the prior written consent of the archivist. Supplying a copy is not an authorization to publish or circulate.

Written permission to publish any records in their entirety or a substantial portion thereof must be requested and approved prior to publication. The researcher has the sole, legal responsibility for obtaining this written permission.
