The Institute attempted to trace the roots of the Jesuits in America through the discovery and collocation of primary source documents as well as historical scholarship. Institute of Jesuit History Collection contains the administrative papers of the Institute as well as the professional papers of its Jesuit members, namely, Ernest J. Burrus, Gerardo Decorme, Jean Delanglez, Gilbert J. Garraghan, Jerome V. Jacobsen, and William E. Shiels.

#### Historical note

The Institute of Jesuit History was founded on June 11, 1936 by president of Loyola University, Chicago Samuel Knox Wilson and Jesuit Father Jerome J. Jacobsen. The Institute attempted to trace the roots of the Jesuits in America through the discovery and collocation of primary source documents as well as historical scholarship. Jesuit fathers William Eugene Shiels, Jean Delanglez, Gilbert J. Garraghan, as well as layman José Manuel Espinosa soon joined Jacobsen as the Institute's founding members.

The Institute took over *Mid-America* magazine, a publication originally geographically focused on historical topics pertinent to the watershed of the Mississippi River, but whose scope was soon extended the Southwest of the United States, including the northern part of Mexico, and the French-speaking part of Canada.

The Institute sponsored the publication of six books and twenty-nine articles by its staff, as well as many other articles on the history of Society by other Jesuits. In 1942, *Mid-America* began to include articles on non-Jesuit topics, and, from 1958 onward, few of the contributions to the magazine were authored by members of the order.

Mid-America remained under the direction of the Institute for Jesuit History until the 1980s. The emergence of other organizations engaged in parallel research, the fatigue of the members of the editorial board, and the deaths and departures of some key members cause the Institute to close in 1981.

## Scope and content note

Institute of Jesuit History Collection contains the administrative papers of the Institute as well as the professional papers of its Jesuit members, namely, Ernest J. Burrus, Gerardo Decorme, Jean Delanglez, Gilbert J. Garraghan, Jerome V. Jacobsen, and William E. Shiels.

The Administrative Papers contains business papers, financial records, as well as the correspondence of *Mid-America* magazine and the Institute of Jesuit History.

The professional papers of Ernest J. Burrus and Gerardo Decorme are very limited in scope. Burrus' papers contain handwritten notes on the *Historia de la Provincia de la Compania de Jesus de Nueva Espania* on three by five notecards. Decorme's papers contain an offprint on Catholic education, notes, and a manuscript entitled "La Historia de la Iglesia del P. Cuevas." Jean Delanglez's professional papers include biographical materials, collected copies archival sources, notes, indices, maps, and subjects. Much of the microfilm in this collection was compiled by Delanglez.

The professional papers of Gilbert J. Garraghan contains photo static copies of archival sources from various Jesuit provinces in America and around the world. Sources from California, the Kentucky Mission, Maryland, the New Orleans Mission, the New York Mission, and the Rocky Mountain Mission, as well as France and the Turin Province are represented. Copies of records of the Indian Office in Washington, DC, materials on the Indian Territory, journals, publications, and general subject files are also included.

The professional papers of Jesuit Jerome V. Jacobsen represent his scholarly work, including articles, journals, and bibliographies, as well as his educational work, including classroom resources, maps, and various student papers.

William E. Shiels's professional papers contain photo static copies of archival documents from a variety of sources, including the Archives of the Province of Mexico, the Regis College Archives, the Archivum Generale Societatis Jesu, the Archivo General de Indias, and the Archives of the German Province. Folders of reference source materials, and research materials are also included. Additional folders on Pedro de Molina (1725), on the Jesuits of the Missouri Province, excerpts of João Lúcio de Azevedo's book *Os jesuitas no Grão-Pará: suas missões e a colonização* are included as topic files.

The microfilm in this collection consists of documents copied from various archives, primarily in Montreal and Paris, by Jean Delanglez.

## Subseries 2.6. William Eugene Shiels, 1920s-1940s (1582-1937)

Scope and content note:

In the subseries of Jesuit William E. Shiels's professional papers are found documents from a variety of archival sources—the Archives of the Province of Mexico (documents from the Superior General, 1582-1659), the Regis College Archives (Toronto), the Archivum Generale Societatis Jesu, the Archivo General de Indias (indices, manuscripts, and maps), and the Archives of the German Province. Also in this subseries are folders of reference source materials, research materials, and documents found by Shiels on a trip through the Midwest United States in 1936. There are three additional folders: one of materials on Pedro de Molina (1725), one of materials on the Jesuits of the Missouri Province, and one with photocopied excerpts of João Lúcio de Azevedo's book (in Portuguese) Os jesuitas no Grão-Pará: suas missões e a colonização [The Jesuits in the Gráo-Pará (Amazon Region of Brazil): Their Missions and the Settlement] (Coimbra: Imprensa da Universidade, 1930; first edition, Lisbon: T. Cardoso, 1901).
